The matter is on calendar for an Evaluation Conference pursuant to Civil Code section 55.54(D). The order for the Evaluation Conference and a mandatory stay of proceedings was entered on November 28, 2012, and set for December 20, 2012.

Appearance by parties is mandatory. Appearance by counsel will not satisfy that requirement.

plaintiff must file with the court and serve on the defendant's at least 15 days before the date of the conference a statement that includes, to the extent reasonable known, for use solely for the purpose of the early evaluation conference, all of the following:

(A) An itemized list of specific conditions on the subject premises that are the basis of the claimed violations of construction-related accessibility standards in the plaintiff's complaint.

(B) The amount of damages claimed.

(C) The amount of attorney's fees and costs incurred to date, if any, that are being claimed.

(D) Any demand for settlement of the case in its entirety.

(E) (1) A party failing to comply with any court order may be subject to court sanctions at the Court's discretion.

Defense counsel and parties-defendant were present at the evaluation conference.
